# **Music Theory**

Ph.D.

### **Objectives**

The University of Minnesota music theory division has four basic areas of study reflecting the expertise of the theory faculty members: Western Art Music (1700-1900); Western Art Music (Post 1900); Popular Music; and Jazz. Interested students are advised to review the theory faculty bios and recent publications on the <u>School of Music website</u> and contact the individual professor whose research interests align with their own for a consultative conversation about whether to apply to the PhD.

## **Admission Requirements**

Applicants must meet the academic standards and general requirements of the Graduate School (grad.umn.edu/admissions) and the School of Music (see cla.umn.edu/music/graduate/apply). Admission is limited to those who exhibit extraordinary potential as scholars and teachers. In addition, applicants are required to submit two analytical papers: one dealing with tonal music and one with post-tonal music. Upon entrance, the student must take a range of placement examinations. Any identified deficiencies must be remedied during the first year of study.

# **Program Requirements**

Doctoral students are required to take at least 15 credits in music beyond the requirement for the M.A.: a total minimum of 39 credits within the field, exclusive of thesis credits. The courses in theory and analysis may include courses in musicology that have a strong analytical or theoretical component. The Graduate School requires a total of 12 credits of course work outside of music, beyond the M.A. requirements (courses in Music Education may be included in fulfilling this requirement). All course work should be chosen in consultation with an advisor, and all course work toward the degree must be taken on an A-F grading basis.

#### Language Requirement

Ph.D. students are required to pass reading comprehension examinations in two foreign languages: German and either French or Italian (certification form required). One of these latter languages may be replaced by a special research technique or collateral field of knowledge at full division and Director of Graduate Studies approval.
